The number of people (inc the instructor) in the practical training area will be strictly limited to a maximum of 2 at any one time. All others should be stood behind a physical barrier at least 2 metres away. 2. The roller shutter door must be kept open during training/work hours to ensure adequate ventilation (the roller shutter door must be barriered off and NOT be used for pedestrian access/exit) 3. Candidates not directly involved with lesson delivery to stand behind their own segregation barriers distanced at 2 metres apart 4. All lift truck hand controls, hand holds, steering wheel, and seat belt buckles etc. must be sanitised regularly throughout the day by the course instructor and as a minimum when a new person is going to use the lift truck 5. Disposable seat covers are supplied and should be swapped by the instructor each time a different candidate operates the lift truck 6. Instructors and candidates should avoid touching their faces 7. Face visors may be worn in addition to a face covering, but not instead of one as face visors do not adequately cover the nose and mouth. 8.
