

## Detailed Guide to ABA Workplace Transport Groupings Changes and what they mean for RTITB Partners

1. Updated Certificates/eCards with new category allocations can be ordered (except for SP1 and M4) and will be supplied for valid (non-expired) qualifications. [Use this form to make the request](#). We're currently working with our database developers to make SP1 and M4 available too.
2. 'Verify' on the RTITB website will be updated to show the new category and course name (where applicable) alongside the old category.
3. Certificates/eCards issued prior to 19th January 2026 with categories which are being removed/superseded remain valid and can continue to be accepted by employers.
